

DECLARATION OF ELIGIBILITY AND ABSENCE OF GROUNDS FOR DISQUALIFICATION

(Interim Head Coach & Coaching Staff, Korea Republic Men's Senior
National Football Team)

Article 10 (Grounds for Disqualification) No person who falls under any of the following items shall be eligible to serve as a member of the National Team, a dedicated support team member, or a match official: [Amended Oct. 6, 2021; Feb. 2, 2026]

1. A person who has been sentenced to imprisonment without prison labor or a more severe penalty, and for whom five (5) years have not elapsed since the completion of, or final remission of, the execution of such sentence;

2. A person who has received a suspended sentence of imprisonment without prison labor or a more severe penalty, and for whom two (2) years have not elapsed since the expiration of the suspension period; or a person who is currently under a deferred sentence for such penalty; [Amended Jul. 5, 2023]

3. A person who has been subjected to a disciplinary sanction of suspension of qualification or a more severe disciplinary sanction by a sports organization—including member sports organizations under Sub-paragraphs (a) through (c) of Article 2, Item 9 of the National Sports Promotion Act, provincial/metropolitan sports councils and their member organizations or branches, and the Korea Paralympic Committee (hereinafter referred to as “Affiliated Sports Organizations”)—and whose period of such disciplinary sanction has not yet expired;

4. A person who has been subjected to a disciplinary sanction of suspension of qualification for a period of less than one (1) year by an Affiliated Sports Organization for an act of violence, and for whom an additional period equal to the duration of such suspension has not elapsed since the date of expiration of the sanction;

5. A person who has been subjected to a disciplinary sanction of suspension of qualification for a period of one (1) year or longer by an Affiliated Sports Organization for an act of violence;

6. A person who has been subjected to a disciplinary sanction of suspension of qualification for a period of less than one (1) year by an Affiliated Sports Organization for misconduct involving sexual harassment, prostitution, or sexual violence (excluding rape and indecent assault under Item 8), and for whom an additional period equal to the duration of such suspension has not elapsed since the date of expiration of the sanction;

7. A person who has been subjected to a disciplinary sanction of suspension of qualification for a period of one (1) year or longer by an Affiliated Sports Organization for misconduct involving sexual harassment, prostitution, or sexual violence (excluding rape and indecent assault under Item 8);

8. A person who has been subjected to a disciplinary sanction of suspension of qualification or a more severe disciplinary sanction by an Affiliated Sports Organization or other related sports body for match-fixing, unfair practices in connection with the selection of national team members or intensive training athletes (including improper selection, collusion, or acceptance of money or improper financial benefits), embezzlement of training funds, breach of trust, or acts of rape or indecent assault;

9. A person who has been subjected to criminal penalties under Article 148-2 of the Road Traffic Act for acts related to driving under the influence, and who falls under any of the following sub-items (including any person whose sentence has lapsed):

(a) A person who has been sentenced to a fine of KRW 5,000,000 (five million) or more, and for whom three (3) years have not elapsed since such sentence became final; or

(b) A person who has been sentenced to a fine of less than KRW 5,000,000 (five million), and for whom two (2) years have not elapsed since such sentence became final;

10. A person who has committed an offense involving gambling under Article 246 or Article 247 of the Criminal Act, and who falls under any of the following sub-items (including any person whose sentence has lapsed):

(a) A person who has been sentenced to a fine exceeding KRW 10,000,000 (ten million), and for whom three (3) years have not elapsed since such sentence became final; or

(b) A person who has been sentenced to a fine of KRW 10,000,000 (ten million) or less, and for whom two (2) years have not elapsed since such sentence became final;

11. A person who has been subjected to a disciplinary sanction of suspension of qualification or suspension from competition for a period of one (1) year or longer by an Affiliated Sports Organization for misconduct causing public controversy, such as school violence or human rights violations;

12. A person who has been subjected to a disciplinary sanction of suspension of qualification or suspension from competition for a period of less than one (1) year by an Affiliated Sports Organization for misconduct causing public controversy, such as school violence or human rights violations, and for whom an additional period equal to the duration of such suspension has not elapsed since the date of expiration of the sanction;

13. A person who has been sentenced to imprisonment without prison labor or a more severe penalty, or medical custody, for an offense set forth under any of the following sub-items, and for whom twenty (20) years have not elapsed since the date on which the execution of such sentence was completed, suspended, or remitted; or a person who has been sentenced to a fine for such offense, and for whom ten (10) years have not elapsed since the date on which such sentence became final: [Newly Established Jul. 5, 2023]

(a) Sexual crimes under Article 2 of the Act on Special Cases Concerning the Punishment, etc. of Sexual Crimes;

(b) Sex offenses against children and juveniles under Article 2, Item 2 of the Act on the Protection of Children and Juveniles against Sex Offenses;

(c) Prohibited acts under Article 4 of the Act on the Punishment of Arrangement of Commercial Sex Acts; or

(d) Sexual harassment under Article 3, Item 2 of the Framework Act on Gender Equality;

14. A sports instructor (including any person whose qualification has been revoked pursuant to Article 12, Paragraph 1 of the National Sports Promotion Act) who has been sentenced to imprisonment without prison labor or a more severe penalty for an offense of bodily injury or assault under Chapter 25, Part II of the Criminal Act committed against an athlete, and for whom ten (10) years have not elapsed since the date on which the execution of such sentence was completed, suspended, or remitted; or [Newly Established Jul. 5, 2023]

15. A person who has been sentenced to a fine of KRW 1,000,000 (one million) or more for an offense set forth under any of the following sub-items, and for whom three (3) years have not elapsed since the date on which such sentence became final:

(a) Offenses set forth under Article 74, Paragraph 1, Items 2 and 3 of the Act on Promotion of Information and Communications Network Utilization and Information Protection; or

(b) Stalking crimes under Article 2, Item 2 of the Act on the Punishment of Crime of Stalking.

As an applicant in the open search process for the position of Interim Head Coach or Coaching Staff member for the Korea Republic Men's National Football Team, I hereby declare that I have personally verified my criminal and investigative background check records as well as my disciplinary history—including any disciplinary actions related to school violence—and confirm that no adverse records exist.

In connection herewith, I agree to strictly comply with Article 10 (Grounds for Disqualification) of the Regulations on National Team Selection and Management, as well as the Operational Guidelines for Intensive Training, when participating in all competitions. I further acknowledge and agree that, should any ground for disqualification be subsequently discovered or verified, the Korea Football Association (KFA) reserves the right to take any necessary action, including but not limited to the invalidation of my application, the revocation of my appointment, or the termination of my engagement agreement. I hereby expressly waive any and all rights to object to, dispute, or contest such actions or any consequences arising therefrom.
